

### Q: How can I access the BECD?

A: You can access the BECD at www.becd.co.uk. For any questions or queries relating to the database, please email becd-support@becd.co.uk. The user guide is at www.becd.co.uk/user-guide, along with video tutorials and FAQs.

### Q: Is the BECD free to use?

A: Yes, it is free to use, to submit data to, and to download data from.

### Q: How is the BECD different from other carbon calculators and everything else that is out there?

A: The BECD is not a calculator. It is a repository for data to be uploaded and downloaded and we hope it will be adopted as the industry-wide method for sharing our knowledge and experiences.

# Q: How and when will the BECD be updated and maintained?

A: The BECD is reliant upon users getting involved and submitting data. The team will release updates when sufficient data has been captured.

# Q: Are there any plans for regular expansion or refinement?

A: We have many things on our BECD wish list, but this is all subject to how the industry adopts and supports it going forward.

### Q: Can one asset detail be shared / co-authored by the whole design team? Or this is an individual user database?

A: At the moment, registration is for individual users, but we'd like to develop a function to share projects between different users.

Q: Are there any plans to directly link with manufacturers?

manufacturers to get involved and upload their data so that BECD users can access the information they need for their products.

Q: Why was MEP data sparse in the presentation?

A: This is an area that is improving in terms of embodied carbon data, but we still have a way to go in the industry before we have EPDs for every product available to us.

the second edition. The second edition takes effect from 1 July 2024. Users will be able to choose to download only projects that are aligned with either one of the editions if they wish.

Q: How can data be downloaded from the BECD? What format is it in?

A: All assessments published in 'full visibility' mode are available to download in a CSV file. The file will contain all the information about the asset, assessment, embodied carbon values, etc. except personal details. You can choose to download all assessments in bulk or select a smaller sample by using filters.

You can perform any type of analysis and research on the export that does not infringe the <u>BECD user</u> agreement.

## A: Yes, although many of the data fields in the Asset database are tailored to the UK context.

#### A: As the BECD is updated to reflect the second edition of the RICS Standard, there will be better provision for infrastructure data.

#### A: Although we will be doing some checks on submitted data when we perform statistical analysis, we can't perform the kind of very detailed analysis that would be needed to validate an assessment.

Simply, BECD is not a third-party verifier of whole life carbon assessments. What we can do is make sure the type of information that is entered by users then allows other users

filter projects out to suit their requirements and, for example, only choose assessments done post-

completion, which restricts the data pool to more accurate projects. Further, we are working on a Data Quality Framework to help users judge the suitability of submitted data. This would rate data against key criteria, for example adherence to standards, level of external review, age of data and what supporting information is available.
