Construction investment announced in the Budget, in total approximately £13bn:

- Schools Committed £1.4 billion to fund the existing school rebuilding programme, an additional £550 million
- Social housing Committed £5 billion to fund the existing Affordable Homes Programme, an additional £500 million
- Prisons Commitment to accelerate the building of new prisons by reforming the planning system
- ► Hospitals Committed an additional £1 billion to upgrade buildings across the NHS estate
- Transport Committed £1 billion for tunnelling on the HS2 link from Old Oak Common to Euston; additional £500 million for roads maintenance
- Other Committed £1 billion for accelerating cladding removal post-Grenfell; £3.4 billion for the Warm Homes Plan



UK HOUSE BUILDING COMPLETIONS BY PROVIDER (ONS, 2024)





From peak in 1970, home completions have declined, particularly local authority provision.

Commercial property developers the largest provider, averaging 157k pa over the last six decades.

SUMMARY



Could Labour have been more ambitious with their budget, and in what way?

A reasonably ambitious budget, but construction could have benefited from greater investment to really get Britain building again.

What's the implication for the project pipeline? If they keep delaying everything, the costs are just going to spiral anyway.

The sector needs certainty so it can plan. We need commitment to the future pipeline of projects asap. Yes, delaying projects today will mean they cost more to deliver in the long-run. Things rarely get cheaper over time.

Does this Budget ensure Labour will hit their target of building 1.5 million homes? Have they gone far enough to ensure this target will be met? What could they also include?

The target is aspirational and nothing more. Likely to deliver close to the long-term average of around 200k new homes per annum or 1 million over the life of the Parliament, a shortfall of 500k. They shouldn't have committed to the target in the first place.
